**CERT Class Fee \$20 – This fee pays for disposable supplies, moulage, and other administrative supply costs for conducting the Basic CERT G317 class. The Fee must be paid prior to attending the first day of class to be included on the roster. No refunds for cancellations within 48 hrs. of the class or no shows.**

**REQUIRED FORMS: Attached is the Rowlett Citizens Corp Council's Waiver Form. This form must be completed, notarized and turned in along with your \$20 fee by Thursday, January 30, 2020. ## WAVIER AND RELEASE AGREEMENT FOR ROWLETT CITIZEN CORPS COUNCIL PROGRAMS

The undersigned, being at least eighteen years of age, and in consideration for acceptance, approval and participation in the **Rowlett Citizen Corps Council, Inc.**, and its affiliated programs, do hereby agree to this waiver and release.

I state that I am free from any known heart, or other serious health problems that could prevent me from participating in any of the activities associated with this program. I further state that I am sufficiently physically fit to participate in the activities of this program.

I recognize that if I am accepted for the program, I may be covered by the provisions of the "Charitable Immunity and Liability Act of 1987" (Texas Code §84), "Good Samaritan Law: Liability For Emergency Care" (Texas Code §74), the "Volunteer Protection Act of 1997" (Federal Public Law 105-19, June 18, 1997), and others during the time that I am performing approved volunteer activities.

I agree to release Rowlett Citizen Corps Council, Inc., its programs, officers, directors, employees, members, volunteers, agents, and all sponsors and/or officials and staff of any said entity or person, their representatives, agents, affiliates, directors, servants, volunteers and employees from any and all liability, claims, demands, actions, and causes of actions whatsoever for any loss claim, damage, injury, illness, attorney's fees or harm of any kind or nature to me arising out of any and all activities associated with the aforementioned activities.

I further agree to hold harmless, and hereby release the above mentioned entities and persons from all liability, negligence, or breach of warranty associated with injuries or damages from any claim by me, my family, estate, heirs, or assigns from or in any way connected with the aforementioned activities.
